Goals

The aim of the course is to introduce the students to the history of European integration theories and practices, and to the specialized literature of European Studies in English. The course is based on reading and analysing the most important theoretical and legal documents of the construction of Europe (1945-2007). The history of the theory and practice of the construction of Europe is analysed within the framework of the theory and practice of international relations, of modernization and globalization. The course concentrates on rethinking the role of the federalist ideas in the construction of Europe, and in the emergence of a democratic international society. Organization of the course (What to do for the mark)

The classes will be a mixture of lectures and seminars. Students are required to prepare presentations on the most important theoretical or legal documents of the construction of Europe. Each participant should choose one legal or theoretical document, and has to present it in 15–20 minutes. The documents themselves can be borrowed from the lecturer, or can be found on the Internet or in the library (see The Theory and Practice of the Construction of Europe. The mark at the end of the semester is given on the basis of the presentation and of the activity during the course.

Course program
